



TERMS & CONDITIONS

This Sponsorship Agreement (hereinafter referred to as the "Agreement" or "Contract") with Healthegy is effective upon receipt of the signed agreement and is applicable to the **Ophthalmology Innovation Summit @ASRS August 10, 2017 and @AAO November 9, 2017**.
